Type of Ownership: Joint or Custodial

Joint with Survivorship-This account is owned by the minor and one or more parent or guardian. Used if more than one parent would like to be able to access funds and minor is able to sign the signature card.

- IAUTMA (Minor Account)- An Iowa Uniform Transfers to Minors Account is an individual account created by a custodian providing a way to legally transfer ownership of funds to a minor while at the same time prohibiting the minor's direct access to the money. The account is owned by the minor (beneficiary) and controlled by the custodian. The custodian has possession and control of the account for the exclusive right and benefit of the minor and barring a court order otherwise, is the only party entitled to make deposits, withdrawals, or close the account. This account is only opened for one minor and names only one custodian. The custodian may name anyone he/she chooses as successor custodian. There are no requirements that the successor custodian be related to the minor.
